**On July 1, 2018, when the Central Vermont Unified Union School District becomes fully operational and begins to provide educational services to students, the school districts of the forming towns (Northfield and Williamstown) shall cease all educational operations and shall remain in existence for the sole purpose of completing any outstanding business not given to the Central Vermont Unified Union School District under the articles agreed upon in the report to the State Board on March 21, 2017 and state law. Meetings beyond June 30, 2018 will be scheduled as needed to complete any outstanding school business as soon as practicable, but in no event any later than December 31, 2018. Upon completion of outstanding business or December 31, 2018, whichever date is earlier, the forming school districts shall cease to exist pursuant to 16 VSA §722. Both the Northfield and Williamstown School Districts shall cease all operations within a reasonable timeframe of the completion of all outstanding business, but in no event any later than January 31, 2019.*
